Election Day is less than three months away; it is imperative to begin educating yourself on candidates and issues if you haven't already done so. The following are some of the pertinent policies, initiatives, and issues at stake regarding disability rights:

- passing the Accessible Voting Act (an Act to make voting more inclusive and accessible)
- ensuring more policy makers with disabilities take active roles in administrations and in government as a whole
- creating inclusive and accessible education, K-12 as well as post-secondary
- ensuring affordable healthcare, equal employment opportunities, and economic security for persons with disabilities
- securing affordable housing and accessible transportation for persons with disabilities

To explore the presidential candidates' platforms and policies pertaining to disability rights, check out the <u>2020 Presidential Primary Candidate Survey on Disability</u> and the American Association of People with Disabilities' (AAPD) <u>resource on Presidential Elections, 2020</u>. The AAPD's <u>REV UP: Register, Educate, Vote, Use Your Power</u> is also a valuable resource, whose mission is to "foster civic engagement and protect the voting rights of Americans with disabilities."

Tuesday, July 28 was National Vote by Mail Day. If you have an illness, physical disability, and/or are at-risk for contracting Covid-19, you may be able to ask for an absentee ballot. Check with your local county voting website. If you are a Boone County resident, the absentee ballot resource is found on the <u>Boone County government site</u>. Boone County residents who have an illness, and/or physical disability, and/or are at-risk for contracting Covid-19 will not have to have their absentee ballots notarized.
